Storm Water Special
Provisions and Forms, and
Department training**

Incorporate the attached storm water special provisions and forms to projects with ESCPs, effective on projects bidding after March 7, 2010. You are not required to put the special provision wholesale into contracts. Instead you may choose to add key information into your existing specifications, or restate the information in your own format and style; provided the requirements are not reduced or omitted.

Should read A 18

Special Provisions ES 18 for Highways Section 641, ~~A-17~~ for Airports P-157, and for facility specifications include:

- SWPPP Preparer information
